A BILL FOR

1 An Act to legalize the proceedings of the town of Buffalo,
2 also known as the city of Buffalo, in Scott County, Iowa,
3 whereby the issuance, sale and delivery of sewer bonds
4 were authorized.

5 WHEREAS it appears from the records of the town council
6 of the town of Buffalo (also known as the city of Buffalo),
7 in Scott county, Iowa, that pursuant to notice published in
8 a newspaper printed and published in Scott county, Iowa, and
9 having a general circulation in said town, the town coun-
10 cil thereof has by resolution authorized and provided for
11 the issuance, sale and delivery of sewer bonds of said town
12 in the amount of two hundred thousand dollars (\$200,000) to
13 pay the cost, to that amount, of improving the municipal sewer
14 system in and for said town, and made provision for the levy
15 of taxes to pay said bonds and the interest thereon; and

16 WHEREAS doubts have arisen concerning the validity and
17 legal sufficiency of said proceedings and provisions made
18 for the issuance and sale of said bonds and for the levy and
19 collection of taxes to pay the principal of and the interest
20 on said bonds as the same become due, and it is deemed
21 advisable to put such doubts and all others that might arise
22 concerning same forever at rest; NOW THEREFORE,

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

24 Section 1. That all proceedings heretofore taken by the
25 town council of the town of Buffalo (also known as the city

1 of Buffalo), in Scott county, Iowa, authorizing and provid-
2 ing for the issuance, sale and delivery of sewer bonds of
3 said town of Buffalo (also known as the city of Buffalo),
4 Iowa, in the amount of two hundred thousand dollars (\$200,000)
5 to pay the cost, to that amount, of improving the municipal
6 sewer system in and for said town, and for the levy of taxes
7 to pay said bonds and interest thereon, are hereby legalized,
8 validated and confirmed and said sewer bonds issued, sold
9 and delivered pursuant to and in accordance with said
10 proceedings are hereby declared to be legal and to consti-
11 tute valid and binding obligations of said town.

12 Sec. 2. This Act, being deemed of immediate importance,
13 shall take effect and be in force from and after its publi-
14 cation in the Muscatine Journal, a newspaper published in
15 Muscatine, Iowa, and in the Times-Democrat, a newspaper pub-
16 lished in Davenport, Iowa, without expense to the state.

EXPLANATION

17
18 This bill legalizes proceedings of the town of Buffalo,
19 Iowa, also known as the city of Buffalo whereby sewer bonds
20 were issued, sold and delivered.
