1 Section 1. Acts of the Sixty-fifth General Assembly,  
2 1973 Session, chapter one (1), section one (1), is amended  
3 by striking subsection twenty-seven (27) and inserting in  
4 lieu thereof the following:

5 27. STATE HISTORICAL DEPARTMENT

6 Salary of the director of the  
7 division of the state historical  
8 society . . . . . \$12,500 \$22,500

9 Salary of the director of the  
10 division of historic preservation . ---- \$16,000

11 Salary of the director of the  
12 division of historical museum  
13 and archives . . . . . \$13,000 \$16,000

14 Sec. 2. The state historical society shall on June 30,  
15 1974 transfer the sum of ten thousand (10,000) dollars from  
16 funds available to it to the general fund of the state.

17 Sec. 3. There is appropriated from the general fund of the  
18 state to the state historical department for the fiscal year  
19 commencing July 1, 1974 and ending June 30, 1975, the sum of  
20 ten thousand (10,000) dollars to be used to supplement the  
21 salary of the director of the division of the state historical  
22 society.

23 Sec. 4. Acts of the Sixty-fifth General Assembly, 1973  
24 Session, chapter one (1), section one (1), is amended by  
25 striking subsection twenty-eight (28).

26 EXPLANATION

27 This bill sets the salary rate, for the 1974-75 fiscal  
28 year, of the director of the division of the state historical  
29 society, who is the former director of the state historical  
30 society, the salary rate of the director of the division of  
31 historical museum and archives, who is the former curator  
32 of the Iowa state department of history and archives, and the  
33 salary rate of the director of a new division of historic  
34 preservation who was formerly an employee of the state con-  
35 servation commission, all within the newly-established state  
36 historical department.
