1 Section 1. Section five hundred eight point eleven  
2 (508.11), Code 1973, is amended by adding the following  
3 new subsection:

4 NEW SUBSECTION. Information determined by the commis-  
5 sioner to be necessary for submission to the national  
6 association of insurance commissioners.

7 Sec. 2. Section five hundred fifteen point sixty-three  
8 (515.63), Code 1973, is amended by adding the following new  
9 unnumbered paragraph.

10 NEW UNNUMBERED PARAGRAPH. Fifteenth--Information  
11 determined by the commissioner to be necessary for sub-  
12 mission to the national association of insurance commis-  
13 sioners.

14 EXPLANATION

15 This bill provides that insurance companies shall be  
16 required to submit as part of their annual report informa-  
17 tion the commissioner of insurance may need in order to  
18 make adequate reports to the National Association of Insur-  
19 ance Commissioners.
