## A BILL FOR

1 An Act relating to transfer of patients to the university  
2 hospital.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

4 Section 1. Section two hundred fifty-five point twenty-  
5 eight (255.28), Code 1973, is amended to read as follows:

6 255.28 TRANSFER OF PATIENTS FROM STATE INSTITUTIONS.

7 The commissioner of the department of social services and  
8 the director of any of the divisions of such department,  
9 and the board in control of the Iowa braille and sight-  
10 saving school, and the Iowa school for the deaf, may,  
11 respectively, send any inmate of any of said institutions,  
12 or any person committed or applying for admission thereto,  
13 to the hospital of the medical college of the state  
14 university for treatment and care as provided in this  
15 chapter, without securing the order of court required in  
16 other cases. Said state department of social services, and  
17 board in control of the Iowa braille and sight-saving school  
18 and the Iowa school for the deaf shall respectively pay the  
19 traveling expenses of any patient thus committed, and when  
20 necessary the traveling expenses of an attendant for such  
21 patient, out of funds appropriated for the use of the  
22 institution from which he is sent.

23 EXPLANATION

24 This bill allows the state board of regents in its  
25 capacity as the board in control of the Iowa braille and

1 sight-saving school, and the Iowa school for the deaf, to  
2 transfer patients to the hospital of the medical college  
3 of the state university for treatment and care without  
4 obtaining an order of court.
