REPORT OF HOUSE COMMITTEE ON APPROPRIATIONS (House File 742)

History and Archives

The committee recommendation is for a budget of \$228,780.00 for 1973-74 and \$242,940.00 for 1974-75.

From this total, \$202,830.00 for 1973-74 and \$209,130.00 for 1974-75 is appropriated for salaries.

\$1,000.00 for 1973-74 and \$1,000.00 for 1974-75 is appropriated for travel.

\$17,250.00 for 1973-74 and \$24,610.00 for 1974-75 is appropriated for office supplies, printing and binding, and telephone and telegraph.

\$7,700.00 for 1973-74 and \$8,000.00 for 1974-75 is appropriated for microfilm, books, periodicals, and publications.

This budget is based on the present level of 25 employees, and provides for no increase in personnel.

1 Section 1. There is appropriated from the general fund
2 of the state to the department of history and archives for
3 each fiscal year of the biennium commencing July 1, 1973 and
4 ending June 30, 1975, the following amounts, or so much thereof
5 as may be necessary, to be used in the manner designated:

10 Sec. 2. No moneys appropriated
11 by this Act shall be used for
12 capital improvements.

13 Sec. 3. Notwithstanding the provisions of section eight
14 point thirty-three (8.33) of the Code, all unencumbered or
15 unobligated balances of appropriations made by this Act for
16 the first fiscal year of the biennium commencing July 1, 1973
17 shall, on August 31, 1974, revert to the state treasury and
18 to the credit of the fund from which appropriated. In all
19 other respects the provisions of section eight point thirty-
20 three (8.33) of the Code shall apply to appropriations made
21 for the first fiscal year of such biennium. Unencumbered
22 or unobligated balances of appropriations made for the second
23 fiscal year of such biennium shall be subject to section eight
24 point thirty-three (8.33) of the Code.

25 Sec. 4. All federal grants to and the federal receipts
26 of the agency receiving funds under this Act are appropriated
27 for the purpose set forth in the federal grants or receipts.

28 Sec. 5. When any laws of this state are in conflict with
29 this Act, the provisions of this Act shall govern for the
30 biennium.
