A BILL FOR

1 An Act making an appropriation from the general fund of the
2 state to the Iowa employment security commission for the
3 administration of the old-age and survivors' insurance sys-
4 tem, federal social security system, and the pension and
5 annuity retirement system for public school teachers.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

7 (House File 755)

8 Employment Security Commission

9 (FICA, IOASI and Teachers Retirement Administration)

10 The committee recommendation is for a budget of \$100,880.00 for 1973-74
and \$100,970.00 for 1974-75.

11 From this total, \$76,420.00 for 1973-74 and \$78,030.00 for 1974-75 is
appropriated for salaries.

12 \$2,500.00 for 1973-74 and \$2,500.00 for 1974-75 is appropriated for travel.

13 \$7,600.00 for 1973-74 and \$7,600.00 for 1974-75 is appropriated for office
supplies and expense.

14 \$1,850.00 for 1973-74 and \$1,200.00 for 1974-75 is appropriated for print-
ing and binding, telephone and telegraph, and equipment.

15 Other expenses, which include data processing rent; utilities; Merit Sys-
tem; State Comptroller and Treasurer; Buildings and Grounds; bonding
and insurance; Court costs; and actuarial service, are appropriated at
16 \$12,510.00 for 1973-74 and \$11,540.00 for 1974-75.

1 Section 1. There is appropriated from the general fund
2 of the state for the fiscal biennium commencing July 1, 1973
3 and ending June 30, 1975 to the Iowa employment security
4 commission the following amounts, or so much thereof as are
5 necessary, to be used in the manner designated:

14 fifteen (294.15) of the Code: \$ 100,880 \$ 100,970

15 Sec. 2. All federal grants to and the federal receipts
16 of the Iowa employment security commission are appropriated
17 for the purpose set forth in the federal grants or receipts.

18 Sec. 3. Notwithstanding the provisions of section eight
19 point thirty-three (8.33) of the Code, all unencumbered or
20 unobligated balances of appropriations made by this Act for
21 the first fiscal year of the biennium commencing July 1, 1973
22 shall, on August 31, 1974, revert to the state treasury and
23 to the credit of the fund from which appropriated. In all
24 other respects the provisions of section eight point thirty-
25 three (8.33) of the Code shall apply to appropriations made
26 for the first fiscal year of such biennium. Unencumbered
27 or unobligated balances of appropriations made for the second
28 fiscal year of such biennium shall be subject to section eight
29 point thirty-three (8.33) of the Code.

30 Sec. 4. When any of the laws of this state are in conflict
31 with this Act, the provisions of this Act shall govern for
32 the bicnnium.
