# A BILL FOR

1 An Act to appropriate from the general fund of the state to  
2 the Iowa state fair board for capital improvements.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

4 (House File 759)

5 State Fair Board—Capitals

6 The committee recommendation is for an appropriation to the State Fair  
7 Board of \$200,000.00 for the next biennium, or so much thereof as may be  
8 necessary for the purpose of major repairs to buildings and grounds.

9 The committee recommendation represents no increase over the previous  
10 biennium.

1 Section 1. There is appropriated from the general fund  
2 of the state to the Iowa state fair board for the biennium  
3 beginning July 1, 1973 and ending June 30, 1975, the sum of  
4 two hundred thousand (200,000) dollars, or so much thereof  
5 as may be necessary, to be used for major repairs to buildings  
6 and grounds.

7 Sec. 2. Before any of the funds appropriated by this Act  
8 shall be expended it shall be determined by the Iowa state  
9 fair board, with the approval of the executive council, that  
10 the expenditure shall be for the best interest of the state.

11 Sec. 3. Where any of the laws of this state are in con-  
12 flict with this Act, the provisions of this Act shall govern  
13 for the biennium.

14 Sec. 4. Any unencumbered or unobligated balances of appro-  
15 priations made by this Act remaining on June 30, 1975 shall  
16 revert to the general fund of the state.
