1 Section 1. There is appropriated from the general fund
2 of the state of Iowa for each fiscal year of the biennium
3 beginning July 1, 1973 and ending June 30, 1975, to the capitol
4 planning commission the following amounts, or so much thereof
5 as may be necessary, to be used for the following purposes:

13 Sec. 2. No moneys appropriated by this Act shall be used
14 for capital improvements.

15 Sec. 3. All federal grants to and the federal receipts
16 of the agency receiving funds under this Act are appropriated
17 for the purpose set forth in the federal grants or receipts.

18 Sec. 4. Notwithstanding the provisions of section eight
19 point thirty-three (8.33) of the Code, all unencumbered or
20 unobligated balances of appropriations made by this Act for
21 the first fiscal year of the biennium commencing July 1, 1973
22 shall, on August 31, 1974, revert to the state treasury and
23 to the credit of the fund from which appropriated. In all
24 other respects the provisions of section eight point thirty-
25 three (8.33) of the Code shall apply to appropriations made
26 for the first fiscal year of such biennium. Unencumbered
27 or unobligated balances of appropriations made for the second
28 fiscal year of such biennium shall be subject to section eight
29 point thirty-three (8.33) of the Code.

30 Sec. 5. When any of the laws of this state are in conflict
31 with this Act, the provisions of this Act shall govern for
32 the biennium.
