## A BILL FOR

1 An Act continuing the appropriation for the Iowa American  
2 revolution bicentennial commission.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

4 Section 1. Acts of the Sixty-fourth General Assembly, 1971  
5 Session, chapter thirty-nine (39), section one (1), is amended  
6 to read as follows:

7 Section 1. There is appropriated from the general fund  
8 of the state to the Iowa American revolution bicentennial  
9 commission for each year of the biennium beginning July 1,  
10 1971 and ending June 30, 1973, the sum of forty thousand  
11 (40,000) dollars, or so much thereof as is necessary for the  
12 purpose of carrying out the purposes and duties of the Iowa  
13 American revolution bicentennial commission as provided in  
14 chapter one thousand two hundred eighty-six (1286) of the  
15 Acts of the Sixty-third General Assembly, Second Session.  
16 Unencumbered funds as of June 30, 1973 appropriated by this  
17 section shall, notwithstanding the provisions of chapter eight  
18 (8) of the Code, be carried over and may be expended during  
19 the fiscal biennium commencing July 1, 1973 and ending June  
20 30, 1975. Any unencumbered funds remaining as of June 30,  
21 1975 shall revert to the general fund as of September 30,  
22 1975.

14 Sec. 3. Notwithstanding the provisions of section  
15 eight point thirty-three (8.33) of the Code, all un-  
16 encumbered or unobligated balances of appropriations  
17 made by this Act for the first fiscal year of the  
18 biennium commencing July 1, 1973 shall, on August 31,  
19 1974, revert to the state treasury and to the credit  
20 of the fund from which appropriated. In all other  
21 respects the provisions of section eight point thirty-  
22 three (8.33) of the Code shall apply to appropriations  
23 made for the first fiscal year of such biennium. Un-  
24 encumbered or unobligated balances of appropriations  
25 made for the second fiscal year of such biennium  
26 shall be subject to section eight point thirty-three  
27 (8.33) of the Code.

28 Sec. 4. All federal grants to and the federal  
29 receipts of the Iowa American revolution bicentennial  
30 commission are appropriated for the purpose set forth  
31 in the federal grants or receipts.

32 Sec. 5. Where any laws of this state are in con-  
33 flict with this Act, the provisions of this Act shall  
34 govern for the biennium."

36 the word "commission" the words "and making an appro-  
37 priation".
