A BILL FOR

1 An Act to make an appropriation from the general fund of the
2 state to the department of general services for capital
3 improvements and repairs for certain buildings and
4 facilities.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. There is appropriated from the general fund
2 of the state of Iowa for the biennium beginning July 1, 1973
3 and ending June 30, 1975, to the division of public buildings
4 and grounds of the department of general services the sum
5 of four hundred eight thousand (408,000) dollars, or so much
6 thereof as may be necessary, to be used for the following
7 purposes:

8 1. To construct an access for physically-handicapped per-
9 sons to the historical building.

10 2. To replace exterior doors to the historical building.

11 3. To convert elevators in the Lucas state office build-
12 ing from manual to automatic operation.

13 4. To replace sidewalks on the perimeter of the capitol
14 grounds.

15 5. To replace walks at the north steps to the capitol
16 building.

17 6. To restore the ceilings on the first floor of the
18 capitol building.

19 7. To replace dome and roof floodlights.

20 8. To restore the stonefacing ballasters at the west
21 steps of the capitol building.

22 9. To repair or replace necessary major utilities and
23 equipment.

24 10. To supplement any prior appropriation for capital
25 improvements.

26 Sec. 2. Before any funds appropriated by this Act are
27 expended, it shall be determined by the director of general
28 services, with the approval of the executive council, that
29 the expenditure is for the best interest of the state.

30 Sec. 3. Any unencumbered balance of the funds appropri-
31 ated by this Act remaining as of June 30, 1975, shall revert
32 to the general fund of the state as of June 30, 1975.
