1 Section 1. There is appropriated from the general fund  
2 of the state for the biennium beginning July 1, 1973 and end-  
3 ing June 30, 1975, for the sewage works construction fund  
4 under section four hundred fifty-five B point sixty-seven  
5 (455B.67) of the Code, the following amounts, or so much  
6 thereof as may be necessary, to be used for the following  
7 purposes:

6     Sec. 2. Section four hundred fifty-five B point seventy  
 7 (455B.70), subsection two (2), Code 1973, is amended by strik-  
 8 ing the subsection and inserting in lieu thereof the follow-  
 9 ing:

10    2. An agreement by the commission to pay to the municipal-  
 11 ity, during the progress of construction or following comple-  
 12 tion of the construction as may be agreed upon by the parties,  
 13 an amount as determined by appropriation of the general  
 14 assembly.

15    Sec. 3. Funds appropriated by this Act shall revert under  
 16 the provisions of section eight point thirty-three (8.33)  
 17 of the Code.

18    Sec. 4. When any of the laws of this state are in conflict  
 19 with this Act, the provisions of this Act shall govern for  
 20 the biennium.
