1 Section 1. There is appropriated from the general fund of
2 the state for the fiscal year beginning July 1, 1973 and ending
3 June 30, 1974 to the secretary of state the sum of ten thousand
4 (10,000) dollars, or so much thereof as may be necessary, to be
5 used to cover the cost of printing, in booklet form and postage
6 for mailing, copies of the Iowa election laws for free distribu-
7 tion.

8 Sec. 2. Notwithstanding the provisions of section eight
9 point thirty-three (8.33) of the Code, all unencumbered or
10 unobligated balances of appropriations made by this Act for
11 the fiscal year commencing July 1, 1973 shall, on August 31,
12 1974, revert to the state treasury and to the credit of the
13 fund from which appropriated. In all other respects the pro-
14 visions of section eight point thirty-three (8.33) of the
15 Code shall apply to appropriations made for the 1973-74 fiscal
16 year.

17 Sec. 3. This Act, being deemed of immediate importance,
18 shall take effect and be in force from and after its publica-
19 tion in the Denison Review, a newspaper published in Denison,
20 Iowa, and in the Times-Democrat, a newspaper published in
21 Davenport, Iowa.
