A BILL FOR

1 An Act making an appropriation from the primary road fund to
2 the state highway commission for construction of a new
3 materials laboratory.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. There is appropriated from the primary road
2 fund to the state highway commission the sum of three million
3 (3,000,000) dollars, or so much thereof as may be necessary, to
4 be used for the construction of a new materials laboratory.

5 Sec. 2. The state highway commission is authorized to
6 obtain and accept any federal grants and funds to the state
7 to be used in connection with the funds appropriated by this
8 Act.

9 Sec. 3. Any unencumbered balance remaining as of June 30,
10 1977 of the appropriation made by this Act shall revert to the
11 primary road fund.

12 Sec. 4. When the state highway commission has approved a
13 project to be financed with funds authorized by this Act, a
14 description of said project and estimated cost shall be reported
15 to the governor and the state comptroller for allocation of
16 funds.

17 Sec. 5. It is the intent of the general assembly that the
18 funds appropriated pursuant to this Act shall be used for the
19 purpose of constructing a new materials laboratory. The
20 materials laboratory is to be located on the real property
21 presently occupied by the state highway commission at Ames, Iowa.
22 The materials laboratory is to contain approximately 65,000
23 square feet and will be located in such a manner that each of
24 the two floors will have a ground level entrance.

2 1. Page 2, by inserting the following new
3 sections after line 16:

4 "Sec. _____. The total estimated cost of the
5 fine arts elements included in the plans and specifi-
6 cations for the new materials laboratory in accor-
7 dance with the purposes of this Act shall be not
8 less than thirty thousand (30,000) dollars. This
9 amount shall not be diminished by professional fees.

10 "Sec. _____. As used in this Act, "fine
11 arts" means sculpture, fountains, bas-reliefs,
12 mosaics, frescoes, wall hangings, pictures or other
13 enhancements to be integrated into the total environ-
14 ment of the new materials laboratory. Fine arts
15 does not include the incidental ornamental detail
16 of functional structural elements or hardware and
17 other accessories.

18 "Sec. _____. The state highway commission
19 shall coordinate with the Iowa arts council on
20 matters relating to the inclusion of works of fine
21 arts authorized by this Act."
