### A BILL FOR

1 An Act to legalize and validate the proceedings of the board  
2 of directors of the Jefferson Community School District  
3 No. 2, in the county of Greene, state of Iowa, authorizing  
4 and providing for the issuance, sale and delivery of school  
5 bonds and for the levy of taxes for the payment of said  
6 bonds and declaring the bonds issued pursuant to said pro-  
7 ceedings to be enforceable obligations of said school dis-  
8 trict.

9 WHEREAS, it appears from the records of the Board of Di-  
10 rectors of the Jefferson Community School District No. 2,  
11 in the County of Greene, State of Iowa, that at a special  
12 school election held in and for said School District on March  
13 19, 1974, the proposition of issuing bonds of said School  
14 District in the amount of Forty-five Thousand Dollars (\$45,000)  
15 for the purpose of improving the high school building grounds  
16 by hard surfacing the student parking lot and driveways and  
17 the teachers' parking lot and driveways in and for said School  
18 District and the proposition of issuing bonds of said School  
19 District in the amount of Ten Thousand Dollars (\$10,000) for  
20 the purpose of improving the junior high school building  
21 grounds by hard surfacing the school bus loading area and  
22 driveways in and for said School District were each approved  
23 by more than sixty percent (60 percent) of the total number  
24 of votes cast for and against each proposition, and in reliance  
25 upon said election said Board of Directors thereafter

1 authorized and provided for the issuance, sale and delivery  
2 of school bonds of said School District to the aggregate  
3 amount of Fifty-five Thousand Dollars (\$55,000) for the purpose  
4 of paying the cost of improving said school building grounds  
5 as aforesaid and made provision for the levy of taxes to pay  
6 said bonds and interest thereon; and

7 WHEREAS, doubts have arisen concerning the validity and  
8 legal sufficiency of said election and proceedings and pro-  
9 visions made for the issuance, sale and payment of said bonds,  
10 and it is deemed advisable to put such doubts and all others  
11 that might arise concerning same forever at rest; NOW THERE-  
12 FORE,

13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

14 Section 1. That all proceedings heretofore taken by the  
15 Board of Directors of the Jefferson Community School Dis-  
16 trict No. 2, in the County of Greene, State of Iowa, pre-  
17 liminary to and in connection with the election on said bonds  
18 held in said School District on March 19, 1974, and providing  
19 for the issuance, sale and delivery of school bonds of said  
20 School District in the aggregate principal amount of Fifty-  
21 five Thousand Dollars (\$55,000) pursuant to said election,  
22 and for the levy of taxes to pay said bonds and interest  
23 thereon, are hereby legalized, validated and confirmed and  
24 said school bonds issued, sold and delivered pursuant to and  
25 in accordance with said proceedings are hereby declared to  
26 be legal and to constitute the valid and binding obligations  
27 of said School District.

28 Sec. 2. This Act, being deemed of immediate importance,  
29 shall take effect and be in force from and after its publi-  
30 cation in The Jefferson Bee, a newspaper published in Jef-  
31 ferson, Iowa, and in The Jefferson Herald, a newspaper pub-  
32 lished in Jefferson, Iowa, without expense to the state.

33 EXPLANATION

34 This bill legalizes a certain school bond issue of the  
35 Jefferson Community School District, the legal sufficiency

1 of which is uncertain because of possible irregularities in  
2 the bond election or related proceedings.
