## A BILL FOR

1 An Act permitting a city or a town to join with a township  
2 in building and maintaining a memorial building.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section thirty-seven point twenty-one (37.21),  
2 Code 1973, is amended to read as follows:

3 37.21 JOINT MEMORIALS. Any city or town may join with  
4 the county or township in which such city or town is located  
5 in the joint erection or purchase of memorial buildings or  
6 monuments and suitable ground and equipment therefor, and the  
7 maintenance thereof, providing the council of such city or  
8 town and the board of supervisors of such county or the town-  
9 ship trustees can so agree, but in cases where commissioners  
10 have already been appointed under section 37.9, such agree-  
11 ment shall be between such commissioners, but if only one of  
12 such parties has appointed commissioners, then such agreement  
13 shall be between the commissioners already appointed and the  
14 council of such city or town or the board of supervisors of  
15 such county or the township trustees, as the case may be.

16 Sec. 2. Section three hundred sixty point four (360.4),  
17 Code 1973, is amended to read as follows:

18 360.4 LOCATION. Any public hall built under the pro-  
19 visions of this chapter shall be located by the township  
20 trustees so as to accommodate the greatest number of the  
21 resident taxpayers, and for such purpose the trustees may  
22 purchase land not to exceed in value five hundred dollars.  
23 They shall also have the power to join with the city or town  
24 authorities of any city or town within their borders and  
25 build and equip said building as a public hall or as a memo-  
26 rial building as provided in section thirty-seven point  
27 twenty-one (37.21) of the Code under such terms and condi-  
28 tions as may be mutually agreed upon.

29 EXPLANATION

30 This bill permits a city or a town to join with a town-  
31 ship to build and maintain a memorial building.
