A BILL FOR

1 An Act to appropriate money from the dairy industry fund to
2 the Iowa dairy industry commission.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

(Senate File 489)

6 The committee recommendation is for an appropriation of \$289,600.00 for
1973-74 and \$289,480.00 for 1974-75.

7 From this total, \$225,000.00 for 1973-74 and \$224,000.00 for 1974-75 is
appropriated for Midland U.D.I.A. dues.

8 \$22,000.00 for 1973-74 and \$22,000.00 for 1974-75 is appropriated for non-
media advertising, displays and exhibits, field services, and printed material.

9 \$14,680.00 for 1973-74 and \$14,670.00 for 1974-75 is appropriated for
office supplies and expense (stationery and supplies, postage, rent, refunds
and miscellaneous) and telephone.

10 The committee recommendation allows for no increase in personnel.

1 Section 1. There is appropriated from the dairy industry
2 fund to the Iowa dairy industry commission under chapter one
3 hundred seventy-nine (179) of the Code for each year of the
4 biennium beginning July 1, 1973 and ending June 30, 1975,
5 the following amounts, or so much thereof as may be necessary,
6 to be used for the following purposes:

12 Sec. 2. Notwithstanding the provisions of section eight
13 point thirty-three (8.33) of the Code, all unencumbered or
14 unobligated balances of appropriations made by this Act for
15 the first fiscal year of the biennium commencing July 1, 1973
16 shall, on September 30, 1974, revert to the state treasury
17 and to the credit of the dairy industry fund from which ap-
18 propriated. The department of agriculture and Iowa dairy
19 industry commission may make application to the committees
20 on appropriations for the reappropriation of any funds that
21 do revert, or probably will revert upon the dates herein set
22 and the respective committees on appropriations or a subcom-
23 mittee thereof shall hold a hearing upon the application while
24 the general assembly is in regular session. In all other
25 respects the provisions of section eight point thirty-three
26 (8.33) of the Code shall apply to appropriations made for
27 the first fiscal year of such biennium. Unencumbered or
28 unobligated balances of appropriations made for the second
29 fiscal year of such biennium shall be subject to section eight
30 point thirty-three (8.33) of the Code.

31 Sec. 3. Where any laws of this state are in conflict with
32 this Act, the provisions of this Act shall govern for the
33 biennium.
