Section 1, subsection 1.

### Interstate Cooperation Commission

The committee recommendation is for an appropriation of \$7,500.00 for 1973-74 and \$7,500.00 for 1974-75, to be used for travel expenses.

Section 1, subsection 2.

### Council of State Governments

The committee recommendation is for an appropriation of \$27,130.00 for 1973-74 and \$27,130.00 for 1974-75, to be used for Iowa's membership assessment.

Section 1, subsection 3.

### Commission on Uniform Laws

The committee recommendation is for budget of \$5,000.00 for 1973-74 and \$5,900.00 for 1974-75.

From this total, \$1,500.00 for 1973-74 and \$2,400.00 for 1974-75 is appropriated for travel.

\$3,500.00 for 1973-74 and \$3,500.00 for 1974-75 is appropriated for support of the National Conference of Commissioners on Uniform State Laws.

1 Section 1. For the following agencies there is appro-  
 2 priated from the general fund of the state for each fiscal  
 3 year of the biennium commencing July 1, 1973 and ending June  
 4 30, 1975, the following amounts, or so much thereof as is  
 5 necessary to be used in the manner designated:

29 Sec. 2. Notwithstanding the provisions of section eight  
 30 point thirty-three (8.33) of the Code, all unencumbered or  
 31 unobligated balances of appropriations made by this Act for  
 32 the first fiscal year of the biennium commencing July 1, 1973  
 33 shall, on August 31, 1974, revert to the state treasury and  
 34 to the credit of the fund from which appropriated. In all  
 35 other respects the provisions of section eight point thirty-

1 three (8.33) of the Code shall apply to appropriations made  
2 for the first fiscal year of such biennium. Unencumbered  
3 or unobligated balances of appropriations made for the second  
4 fiscal year of such biennium shall be subject to section eight  
5 point thirty-three (8.33) of the Code.

6 Sec. 3. Where any laws of this state are in conflict with  
7 this Act, the provisions of this Act shall govern for the  
8 biennium.
