1 An Act making an appropriation from the general fund to the
2 Iowa law enforcement academy.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

The committee recommendation is for an appropriation of \$255,300.00 for 1973-74 and \$259,850.00 for 1974-75.

9

From this total, \$159,700.00 for 1973-74 and \$165,500.00 for 1974-75 is appropriated for salaries.

10

\$9,000.00 for 1973-74 and \$7,000.00 for 1974-75 is appropriated for travel.

11

\$15,000.00 for 1973-74 and \$15,250.00 for 1974-75 is appropriated for office supplies and expense, printing and binding, telephone and telegraph, and equipment.

Other expenses, which include housekeeping, insurance, professional and scientific, building rental, training equipment, and training supplies and expenses are appropriated at \$66,700.00 for 1973-74 and \$67,200.00 for 1974-75.

The committee recommendation allows for no increase in personnel.

1 Section 1. There is appropriated from the general fund
2 of the state for the Iowa law enforcement academy for the
3 biennium beginning July 1, 1973 and ending June 30, 1975,
4 the following amounts, or so much thereof as may be neces-
5 sary, to be used in the manner designated:

12 Sec. 2. All federal grants to and the federal receipts
13 of the Iowa law enforcement academy are appropriated for the
14 purpose set forth in the federal grants or receipts.

15 Sec. 3. No funds appropriated by this Act shall be used
16 for capital improvements.

17 Sec. 4. Notwithstanding the provisions of section eight
18 point thirty-three (8.33) of the Code, all unencumbered or
19 unobligated balances of appropriations made by this Act for
20 the first fiscal year of the biennium commencing July 1, 1973
21 shall, on August 31, 1974, revert to the state treasury and
22 to the credit of the fund from which appropriated. In all
23 other respects the provisions of section eight point thirty-
24 three (8.33) of the Code shall apply to appropriations made
25 for the first fiscal year of such biennium. Unencumbered
26 or unobligated balances of appropriations made for the second
27 fiscal year of such biennium shall be subject to section eight
28 point thirty-three (8.33) of the Code.

29 Sec. 5. When any of the laws of this state are in con-
30 flict with this Act, the provisions of this Act shall govern
31 for the biennium.
