1 Section 1. There is appropriated from the general fund
 2 of the state to the office of citizens' aide for the fiscal
 3 biennium commencing July 1, 1973 and ending June 30, 1975,
 4 the following amounts, or so much thereof as is necessary,
 5 to be used for the purposes designated:

20 Sec. 2. All federal grants to and the federal receipts
 21 of the office of citizens' aide are appropriated for the
 22 purpose set forth in the federal grants or receipts.

23 Sec. 3. Notwithstanding the provisions of section eight
 24 point thirty-three (8.33) of the Code, all unencumbered or
 25 unobligated balances of appropriations made by subsection
 26 one (1) of section one (1) of this Act for the first fiscal
 27 year of the biennium commencing July 1, 1973 shall, on August
 28 31, 1974, revert to the state treasury and to the credit of
 29 the fund from which appropriated. In all other respects the
 30 provisions of section eight point thirty-three (8.33) of the
 31 Code shall apply to appropriations made by this Act for the
 32 first fiscal year of such biennium. Unencumbered or
 33 unobligated balances of appropriations made for the second
 34 fiscal year of such biennium shall be subject to section eight
 35 point thirty-three (8.33) of the Code.

1 Sec. 4. When any of the laws of this state are in con-
2 flict with this Act, the provisions of this Act shall govern
3 for the biennium.
