A BILL FOR

1 An Act to make an appropriation from the general fund of the
2 state to the Iowa state arts council.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. There is appropriated from the general fund
2 of the state of Iowa for each fiscal year of the biennium
3 beginning July 1, 1973 and ending June 30, 1975, to the Iowa
4 state arts council the following amounts, or so much thereof
5 as may be necessary, to be used for the following purposes:

18 Sec. 2. No moneys appropriated by this Act shall be used
19 for capital improvements.

20 Sec. 3. All federal grants to and the federal receipts
21 of the Iowa state arts council are appropriated for the pur-
22 pose set forth in the federal grants or receipts.

23 Sec. 4. Notwithstanding the provisions of section eight
24 point thirty-three (8.33) of the Code, all unencumbered or
25 unobligated balances of appropriations made by this Act for
26 the first fiscal year of the biennium commencing July 1, 1973
27 shall, on August 31, 1974, revert to the state treasury and
28 to the credit of the fund from which appropriated. In all
29 other respects the provisions of section eight point thirty-
30 three (8.33) of the Code shall apply to appropriations made
31 for the first fiscal year of such biennium. Unencumbered
32 or unobligated balances of appropriations made for the second
33 fiscal year of such biennium shall be subject to section eight
34 point thirty-three (8.33) of the Code.

35 Sec. 5. When any of the laws of this state are in conflict

1 with this Act, the provisions of this Act shall govern for
2 the biennium.

4 Iowa Arts Council

5 The committee recommendation is for a budget of \$65,400 for 1973-74 and
6 \$64,190 for 1974-75. The state appropriation for this budget is \$50,300 for
7 1973-74 and \$49,190 for 1974-75. That portion of federal funds which can
8 be used for administrative purposes, and which are also included in the
9 budget total but are not a part of the state appropriation, will be \$15,000
10 for 1973-74 and \$15,000 for 1974-75.

11 From this budget total, \$32,120 for 1973-74 and \$32,930 for 1974-75
12 is appropriated for salaries.

13 \$5,210 for 1973-74 and \$5,210 for 1974-75 is appropriated for travel.

14 Special projects which are matched with federal grants are appropriated
15 at \$20,300 for 1973-74 and \$19,000 for 1974-75.

16 Direct expense for special projects not matched with federal grants are
17 appropriated at \$1,500 for 1973-74 and \$1,500 for 1974-75.

18 \$500 for 1973-74 and \$500 for 1974-75 is appropriated for dues.

19 Other expenses, which include office supplies and expense; printing and
20 binding; telephone and telegraph; and equipment are appropriated at \$5,770
21 for 1973-74 and \$5,050 for 1974-75.

22 The committee recommendation provides for no increase in personnel.
