A BILL FOR

1 An Act to appropriate funds from the general fund to the Iowa
2 crime commission for the purpose of matching federal funds
3 to support certain activities within local government units.
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. There is appropriated from the general fund
2 of the state to the Iowa crime commission for each year of
3 the biennium commencing July 1, 1973 and ending June 30, 1975,
4 the following amounts, or so much thereof as may be neces-
5 sary, to be used in the manner designated:

10 commission through the Omnibus
11 Crime Control and Safe Streets
12 Act of 1968 as amended by the
13 Omnibus Crime Control Act of
14 1970:

15 Sec. 2. The funds appropriated in this Act constitute
16 a portion of the federal statutory requirement to provide
17 in the aggregate not less than one-fourth of the nonfederal
18 funding for projects conducted by units of general local
19 government or combinations of such units for the development
20 and implementation of programs and projects for the improve-
21 ment of law enforcement.

22 Sec. 3. Any allocation of funds from this appropriation
23 shall be approved by the state comptroller and the governor.

24 Sec. 4. Notwithstanding the provisions of section eight
25 point thirty-three (8.33) of the Code, all unencumbered or
26 unobligated balances of appropriations made by this Act for
27 the first fiscal year of the biennium commencing July 1, 1973
28 shall on June 30, 1977 revert to the state treasury and to
29 the credit of the fund from which appropriated. In all other
30 respects the provisions of section eight point thirty-three
31 (8.33) of the Code shall apply to appropriations made for
32 the first fiscal year of such biennium. Unencumbered or un-
33 obligated balances of appropriations made for the second
34 fiscal year of the biennium shall be subject to section eight
35 point thirty-three (8.33) of the Code, except that all un-

1 encumbered or unobligated balances of the appropriation shall
2 revert to the credit of the fund from which appropriated on
3 June 30, 1978.

4 Sec. 5. When any provisions of the laws of this state
5 are in conflict with this Act, the provisions of this Act
6 shall govern for the biennium.

8 Law Enforcement

9 The committee recommendation is for an appropriation of \$145,000 for
10 1973-74 and \$186,000 for 1974-75, which is the state's contribution for
11 matching federal funds from the Law Enforcement Assistance Administra-
12 tion.

13 This appropriation will bring an anticipated \$7,431,000 for 1973-74 and
14 \$8,574,000 for 1974-75 in federal aid.
