1 Section 1. Section three hundred twenty-one point two
2 hundred thirty-eight (321.238), subsection two (2), Code 1973,
3 is amended to read as follows:

4 2. Application for an authorized inspection station permit
5 shall be made upon forms provided by the commissioner. The
6 ~~biennial~~ annual fee for an inspection station permit shall
7 be ~~five~~ ten dollars. The fee shall be submitted with the
8 application for the permit and annually thereafter.

9 Sec. 2. Section three hundred twenty-one point two hun-
10 dred thirty-eight (321.238), subsection nine (9), Code 1973,
11 is amended to read as follows:

12 9. All fees collected by the department under the pro-
13 visions of this section shall be remitted monthly to the
14 treasurer of state. The moneys remitted shall be placed by
15 the treasurer of state in a special fund to be known as the
16 "motor vehicle inspection fund" and shall be used to defray
17 the cost of administering the provisions of this section.
18 Any unencumbered balance in excess of twenty thousand dollars
19 remaining in the motor vehicle inspection fund at the end
20 of each fiscal year shall revert to the general fund of the
21 state on the thirtieth day of September following the end
22 of the fiscal year.
