Amend House File 1036 as follows:

1. Page 1, by adding after line 15 the following new section:

"Sec. 2. Salaries of employees of agencies appropriated funds under this Act as they exist on June 30, 1976 shall be increased by five percent rounded to the nearest dollar amount divisible by twenty-six to provide for a cost of living adjustment. This section shall not apply to employees for whom the general assembly specifically provides a salary rate.

There is appropriated from the general fund of the state for the fiscal year beginning July 1, 1976 and ending June 30, 1977, the sum of \$90,402, or so much thereof as is necessary to carry out the provisions of this section."

AN ACT

MAKING AN APPROPRIATION TO AGENCIES RESPONSIBLE FOR THE ADMINISTRATION OF ENERGY AND ENVIRONMENTAL PROGRAMS INCLUDING THE ENERGY POLICY COUNCIL AND THE DEPARTMENT OF ENVIRONMENTAL QUALITY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state for the fiscal year beginning July 1, 1976 and ending June 30, 1977 to the following agencies the funds indicated to be used in the manner designated:

1. ENERGY POLICY COUNCIL

For salaries and support for not more than seven full-time permanent positions, and maintenance, and miscellaneous purposes..... \$ 210,000

2. DEPARTMENT OF ENVIRONMENTAL QUALITY

For salaries and support of not more than one hundred forty-six full-time permanent positions, and maintenance, and miscellaneous purposes..... \$1,618,231

Sec. 2. All federal grants to and the federal receipts of the agencies receiving funds under this Act are appropriated for the purpose set forth in such federal grants or receipts.
