BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section two hundred fifty-nine A point two (259A.2), Code 1975, as amended by Acts of the Sixty-sixth General Assembly, 1975 Session, chapter one hundred fifty-four (154), section two (2), is amended by striking unnumbered paragraph two (2) and inserting in lieu thereof the following:

Application shall be made to a testing center approved by the department of public instruction, accompanied by an application fee in an amount prescribed by the department. The test scores shall be forwarded by the testing center to the department.
