1 Section 1. Section two hundred fifty-seven point eight  
2 (257.8), Code 1975, is amended to read as follows:

3 257.8 REGULAR AND SPECIAL MEETINGS. The state board shall  
4 hold at least six regular meetings each year~~7--the-first-of~~  
5 ~~which-shall-be-on-the-second-secular-day-of-January.~~ The  
6 first regular meeting shall be held on the second Thursday  
7 in January for purposes of organization. Special meetings  
8 of the state board may be called by the president or by any  
9 five members of the board on five days' notice given to each  
10 member. All meetings shall be held at the office of the  
11 department of public instruction unless a different place  
12 within the state of Iowa is designated by the state board  
13 or in the notice of the meeting.

14 EXPLANATION

15 This bill changes the date of the first regular meeting  
16 of the state board of public instruction from the second  
17 secular day of January to the second Thursday in January and  
18 requires that the state board organize on that date.

## AN ACT

RELATING TO THE DATE OF ORGANIZATION OF THE STATE BOARD  
OF PUBLIC INSTRUCTION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section two hundred fifty-seven point eight  
(257.8), Code 1975, is amended to read as follows:

257.8 REGULAR AND SPECIAL MEETINGS. The state board shall  
hold at least six regular meetings each year, ~~the first of~~  
~~which shall be on the second secular day of January.~~ The  
first regular meeting shall be held on the second Thursday  
in January for purposes of organization. Special meetings  
of the state board may be called by the president or by any

within the state of Iowa is designated by the state board  
or in the notice of the meeting.
