1 Section 1. There is appropriated from the Iowa public  
2 employees' retirement system fund for the fiscal year beginning  
3 July 1, 1975 and ending June 30, 1976 to the employment  
4 security commission the sum of eight hundred fifty-one thousand  
5 one hundred fifty-two (\$851,152) dollars, or so much thereof  
6 as may be necessary, to be used for salaries, support,  
7 maintenance and miscellaneous purposes.

8 Sec. 2. Notwithstanding the provisions of section eight  
9 point thirty-three (8.33) of the Code, all unencumbered or  
10 unobligated balances of appropriations made by this Act for  
11 the fiscal year beginning July 1, 1975 remaining on June 30,  
12 1976 shall revert to the general fund on August 31, 1976.  
13 In all other respects the provisions of section eight point  
14 thirty-three (8.33) of the Code shall apply to this Act.

15 EXPLANATION

16 This bill transfers funds from the IPERS fund to the  
17 employment security commission for the cost of administering  
18 the IPERS program. The number of authorized positions remains  
19 the same as the current table of organization.

Section 1. There is appropriated from the Iowa public employees' retirement system fund for the fiscal year beginning July 1, 1975 and ending June 30, 1976 to the employment security commission the sum of eight hundred fifty-one thousand one hundred fifty-two (\$851,152) dollars, or so much thereof as may be necessary, to be used for salaries, support, maintenance and miscellaneous purposes.

Sec. 2. Notwithstanding the provisions of section eight point thirty-three (8.33) of the Code, all unencumbered or unobligated balances of appropriations made by this Act for the fiscal year beginning July 1, 1975 remaining on June 30, 1976 shall, on August 31, 1976, revert to the state treasury and to the credit of the fund from which appropriated.
