AN ACT

MAKING AN APPROPRIATION TO PAY ATTORNEY FEES AND EXPENSES FOR COUNSEL FOR THE PARTIES IN THE ELECTION CONTEST OF SPRADLING v. STEPHENS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state to the following named law firms the amount set opposite their names, or so much thereof as is necessary, in full payment of all claims they may have against the state on account of services rendered and expenses incurred in the election contest of Spradling v. Stephens:

- 1. Klay, Bastemeyer and Veldhuizen, P.C.  
Orange City, Iowa..... \$833.17
- 2. TePaske and Evans  
Sioux Center, Iowa..... \$850.00

Sec. 2. The state comptroller is authorized to issue warrants to the above named parties in the amounts stated, or so much thereof as is necessary, and the treasurer of state shall pay the same from the general fund of the state.

Sec. 3. The acceptance of funds appropriated by this Act by the named parties shall be in full settlement of all claims against the state because of the above described claims.
