1 Section 1. There is appropriated from the general fund
2 of the state to the Iowa arts council and the academy of
3 science for the fiscal year beginning July 1, 1976, and ending

19 EXPLANATION

20 1. Iowa Arts Council. This appropriation of \$200,500
21 allows for the continuation of current programs with no
22 additions to the current table of organization. \$120,000
23 was included for state match for special projects. Federal
24 funds in the amount of \$300,000 are anticipated.

25 2. Iowa Academy of Science. This appropriation of \$8,000
26 supplements the Iowa Academy of Science publication costs.

AN ACT

APPROPRIATING FUNDS TO THE IOWA STATE ARTS COUNCIL AND THE
ACADEMY OF SCIENCE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state to the Iowa arts council and the academy of science for the fiscal year beginning July 1, 1976, and ending June 30, 1977, the following amounts, or so much thereof as may be necessary, to be used in the manner designated:

- 1. IOWA STATE ARTS COUNCIL.
For salaries, support, maintenance and
miscellaneous purposes.....\$ 200,500
- 2. IOWA ACADEMY OF SCIENCE
To supplement publication costs.....\$ 8,000

Sec. 2. All federal grants to and the federal receipts of the agencies appropriated funds under this Act are appropriated for the purposes set forth in such federal grants or receipts.

Sec. 3. Moneys appropriated by this Act shall not be used for capital improvements.
