11 EXPLANATION

12 A salary range for the director of the Iowa real estate
13 commission was inadvertently omitted from the salary range
14 law enacted in 1975. Since section 117.11 of the Code re-
15 quires the general assembly to set such salary, the director
16 has received no salary increase in the same manner as other
17 officials contained in chapter 3 of the 1975 Acts.
