20 BUREAU OF LABOR

21 The appropriation of \$891,637 funds the following programs:  
22 Administration, Wage Payment, Amusement Park-Ride Inspection,  
23 Boiler Inspection, Elevator Inspection, Safety and Health  
24 Education, Work Place Standards, Research and Statistics,  
25 Iowa Occupational and Safety Health Inspection. Federal match  
26 in the amount of \$553,789 is anticipated. Funding has been  
27 included for reallocations in the Administrative Division.  
28 Also funds for one hearing officer in the Wage Payment Division  
29 have been included in this appropriation to replace CETA funds  
30 which will expire June 30, 1976. An additional \$44,179 has  
31 been included for OSHA Education.

32 MERIT

33 This appropriation in the amount of \$804,004 funds the  
34 current Table of Organization plus seven new positions. Funds  
35 for equipment have been included for the new positions. Also

1 funds for contractual services and supervisory training are  
2 included in this appropriation.
