1 Section 1. There is appropriated from the motor vehicle
2 fuel tax fund to the department of revenue for the fiscal
3 year beginning July 1, 1976 and ending June 30, 1977, the
4 sum of one million two hundred ninety-one thousand four hundred
5 sixty-two (1,291,462) dollars, or so much thereof as may be
6 necessary, for salaries, support, maintenance and miscella-
7 neous purposes for administration and enforcement of the
8 provisions of chapter three hundred twenty-four (324) of the
9 Code and the motor vehicle use tax program.

EXPLANATION

11 This appropriation from the motor vehicle fuel tax fund
12 transfers funds to the department of revenue for administra-
13 tive purposes. Funds are provided for positions on the cur-

AN ACT

RELATING TO ADMINISTRATION OF CHAPTER THREE HUNDRED TWENTY-FOUR (324) OF THE CODE AND THE MOTOR VEHICLE USE TAX PROGRAM AND APPROPRIATING FUNDS FROM THE MOTOR VEHICLE FUEL TAX FUND TO THE DEPARTMENT OF REVENUE FOR SUCH PURPOSES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the motor vehicle fuel tax fund to the department of revenue for the fiscal year beginning July 1, 1976 and ending June 30, 1977, the sum of one million two hundred ninety-one thousand four hundred sixty-two (1,291,462) dollars, or so much thereof as may be necessary, for salaries, support, maintenance and miscellaneous purposes for administration and enforcement of the provisions of chapter three hundred twenty-four (324) of the Code and the motor vehicle use tax program.
