1 Section 1. There is appropriated from the general fund
2 of the state for the fiscal year beginning July 1, 1976 and
3 ending June 30, 1977 to the Iowa state commerce commission,
4 utilities division, the sum of one hundred fifty thousand
5 (150,000) dollars, or so much thereof as is necessary, for
6 salaries, support, maintenance, and miscellaneous purposes
7 of staff in the utilities division. Funds appropriated by
8 this Act are in addition to any other funds appropriated to
9 the Iowa state commerce commission, utilities division.

10 EXPLANATION

11 This bill appropriates funds to the utilities division
12 of the Iowa state commerce commission for staff needs.
13 Specifically, it is contemplated that funds will be used for
14 inspectors, economists, financial examiners, and a clerk
15 typist. The staff personnel will be used for increased case
16 load, new projects such as nuclear plants and liquified natural
17 gas plants, and utility plant siting and determination of
18 utility plant service areas.

AN ACT

MAKING AN APPROPRIATION FOR FUNDING OF STAFF FOR THE UTILITIES DIVISION OF THE IOWA STATE COMMERCE COMMISSION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state for the fiscal year beginning July 1, 1976 and ending June 30, 1977 to the Iowa state commerce commission, utilities division, the sum of one hundred fifty thousand (150,000) dollars, or so much thereof as is necessary, for salaries, support, maintenance, and miscellaneous purposes of staff in the utilities division. Funds appropriated by this Act are in addition to any other funds appropriated to the Iowa state commerce commission, utilities division.
