1 An Act providing that for the purposes of chapter three

3 transmission facilities may include the right to the

1 Section 1. Section three hundred ninety point one (390.1),
2 Code 1975, as amended by Acts of the Sixty-sixth General As-

6 NEW SUBSECTION. "Own and ownership" in the case of trans-
7 mission facilities, including substations and associated fa-
8 cilities, which are located in Iowa, may include the right
9 to the use of an amount of the capacity thereof, if the joint
10 agreement so provides.

11 EXPLANATION

12 This bill would enable municipally-owned electric systems
13 to purchase transmission capacity which is necessary for
14 immediate and future power deliveries.

AN ACT

PROVIDING THAT FOR THE PURPOSES OF CHAPTER THREE HUNDRED NINETY (390) OF THE CODE, OWNERSHIP OF CERTAIN TRANSMISSION FACILITIES MAY INCLUDE THE RIGHT TO THE USE OF AN AMOUNT OF THE CAPACITY THEREOF.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section three hundred ninety point one (390.1), Code 1975, as amended by Acts of the Sixty-sixth General Assembly, 1975 Session, chapter one hundred ninety-nine (199), section one (1), is amended by adding the following new subsection:

NEW SUBSECTION. "Own and ownership" in the case of transmission facilities, including substations and associated facilities, which are located in Iowa, may include the right to the use of an amount of the capacity thereof, if the joint agreement so provides.
