1 Section 1. Section six hundred twenty-five point nineteen
2 (625.19), Code 1975, is amended to read as follows:

3 625.19 COSTS IN SUPREME COURT. When the costs accrued
4 in the supreme court and the trial court are paid to the clerk
5 of the trial court, he shall pay ~~so-much-of~~ them ~~as-accrued~~
6 ~~in-the-supreme-court~~ to the ~~clerk-of-said-court,-and-take~~
7 ~~his-receipt-therefor~~ persons entitled thereto.

8 Sec. 2. Section six hundred twenty-five point twenty
9 (625.20), Code 1975, is repealed.

10 EXPLANATION

11 This bill changes the procedures for the payment of costs
12 awarded by the supreme court. At the present time it is the
13 supreme court clerk's responsibility to prepare a complete
14 bill of costs and file it with the trial court clerk. When
15 the costs are paid to the clerk of trial court, he pays the
16 appellate costs to the supreme court clerk. The supreme court
17 clerk then pays them to the persons entitled to them. Under
18 this bill the responsibility of disbursing appellate costs
19 to the appropriate persons would be shifted to the trial court
20 clerk who receives the funds initially, thereby providing
21 for more efficient operations.

AN ACT
RELATING TO THE DISBURSEMENT OF COSTS IN ACTIONS ON APPEAL
TO THE SUPREME COURT.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section six hundred twenty-five point nineteen (625.19), Code 1975, is amended to read as follows:

625.19 COSTS IN SUPREME COURT. When the costs accrued in the supreme court and the trial court are paid to the clerk of the trial court, he shall pay ~~so-much-of~~ them ~~as-accrued in-the-supreme-court~~ to the ~~clerk-of-said-court,-and-take his-receipt-therefor~~ persons entitled thereto.

Sec. 2. Section six hundred twenty-five point twenty (625.20), Code 1975, is repealed.
