4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. There is appropriated from the general fund
2 of the state to the department of public instruction for the
3 fiscal year beginning July 1, 1975 and ending June 30, 1976
4 the following amount, or so much thereof as is necessary,
5 to be used for administration of the program for driver
6 education courses:

21 EXPLANATION

22 Appropriation to the department of public instruction.
23 The administrative functions of the driver education courses
24 by the department of public instruction continue in accor-
25 dance with section 321.178 of the Code excepting receipt
26 and disbursement of state funds to local school districts.
27 Funds for local school districts will be distributed begin-
28 ning July 1, 1975 through the school foundation plan. Here-
29 tofore, the administrative costs were allowed as a percentage
30 of the total appropriation made for driver education courses
31 to local school districts.

AN ACT

MAKING AN APPROPRIATION TO THE DEPARTMENT OF PUBLIC IN-
STRUCTION FOR THE ADMINISTRATION OF DRIVER EDUCATION
COURSES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state to the department of public instruction for the fiscal year beginning July 1, 1975 and ending June 30, 1976 the following amount, or so much thereof as is necessary, to be used for administration of the program for driver education courses:

General office administration

For salaries, support, maintenance and miscellaneous purposes for administering the program for driver education courses pursuant to the provisions of section three hundred twenty-one point one hundred seventy-eight (321.178) of the Code\$ 63,000

Sec. 2. All federal grants to and the federal receipts of the agencies appropriated funds under this Act are appropriated for the purposes set forth in such federal grants or receipts.

Sec. 3. Funds appropriated by this Act shall not be used for capital improvements.
