A BILL FOR

1 An Act making an appropriation for per diem and expenses of
2 the legislative council, legislative fiscal committee,
3 and special interim study committees and providing for
4 administration of the funds appropriated.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. There is appropriated from the general fund
2 of the state for the fiscal year beginning July 1, 1975 and
3 ending June 30, 1976 the following amounts, or so much there-
4 of as is necessary, for use of the agencies and for the
5 purposes designated: /

6 1. Legislative council

7 For payment of per diem and
8 expenses of members of the leg-
9 islative council and special
10 interim study committees\$ 86,000

11 2. Legislative fiscal com-
12 mittee

13 For payment of per diem and
14 expenses of members of the leg-
15 islative fiscal committee\$ 25,000

16 Sec. 2. Section two point sixty-six (2.66), Code 1975,
17 is amended to read as follows:

18 2.66 OFFICE AND SUPPLIES--EXPENSES. The office of the
19 service bureau shall be located in the statehouse. Supplies,
20 postage, and equipment may be requisitioned from the execu-
21 ~~tive-council~~ department of general services. Per-diem
22 ~~and-expenses~~ Expenses of the legislative council, special
23 ~~interim-study-committees,~~ and service bureau shall be paid
24 upon the approval of the director of the bureau and, if an
25 extraordinary expense, upon the approval of the legislative
26 council or its chairman. Funds appropriated for per diem and
27 expenses of the legislative council, legislative fiscal com-
28 mittee, and special interim study committees shall be paid and
29 administered in the manner provided by the legislative coun-
30 cil.

31 EXPLANATION

32 This bill appropriates funds for per diem and expenses
33 of the legislative council, legislative fiscal bureau and
34 special interim study committees. The amendment to section
35 2.66 allows the legislative council to establish a procedure

1 whereby house members could be paid through the house finance
2 clerk and senate members through the senate finance clerk
3 and thus duplication of payment and administrative procedures
4 could be avoided by transferring such payment procedure from
5 the legislative service bureau and the legislative fiscal
6 bureau.
