2 1. Page 1, by inserting after line 12 the
3 following:

4 "Sec. 2. The provisions of section two hundred
5 forty-five point sixteen (245.16) of the Code shall
6 apply to the return of escaped, paroled, or released
7 inmates of institutions or programs established
8 pursuant to chapters two hundred forty-two (242),
9 two hundred forty-four (244), two hundred forty-six
10 (246), two hundred forty-six A (246A), two hundred
11 forty-seven (247), and two hundred forty seven A
12 (247A) of the Code."

13 2. Title page, line 3, by inserting after the
14 word "facility" the words "and other correctional
15 institutions".

1 Section 1. Chapter two hundred forty-six (246), Code 1977,

10 to the inmates at the women's reformatory and the Iowa security

12 EXPLANATION

13 This bill makes it explicit that the provisions contained
14 in the chapter on the penitentiary and men's reformatory
15 regarding insurrection, credit for time served, reduction
16 of sentence ("good time"), forfeiture of reduction, separate
17 sentences, and special reductions for trustees also apply
18 to the inmates of the women's reformatory and the Iowa security
19 medical facility.

AN ACT

TO CLARIFY THE APPLICABILITY OF CERTAIN SECTIONS TO THE
WOMEN'S REFORMATORY AND THE IOWA SECURITY MEDICAL
FACILITY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Chapter two hundred forty-six (246), Code 1977,
is amended by adding the following new section:

NEW SECTION. APPLICABILITY TO OTHER INSTITUTIONS. The
provisions of sections two hundred forty-six point thirty-
three (246.33), two hundred forty-six point thirty-eight
(246.38), two hundred forty-six point thirty-nine (246.39),
two hundred forty-six point forty-one (246.41), two hundred
forty-six point forty-two (246.42), and two hundred forty-
six point forty-three (246.43) of the Code shall also apply
to the inmates at the women's reformatory and the Iowa security
medical facility.
