1 Section 1. There is appropriated from the general fund
2 of the state to the state department of health the sum of
3 fifteen thousand (15,000) dollars, or so much thereof as is
4 necessary, to be used to pay the cost of medical examinations
5 for the purpose of gathering evidence and the cost of treat-
6 ment for the purpose of preventing venereal disease as required
7 by section seven hundred nine point ten (709.10) of the Code
8 1977 Supplement.

9 Sec. 2. Unencumbered or unobligated balances of funds
10 appropriated by this Act remaining on June 30, 1979 shall
11 revert to the general fund of the state.

12 Sec. 3. This Act, being deemed of immediate importance,
13 shall take effect and be in force from and after its publica-
14 tion in The Waterloo Courier, a newspaper published in
15 Waterloo, Iowa, and in The Belle Plaine Union, a newspaper
16 published in Belle Plaine, Iowa.

17 EXPLANATION

AN ACT

MAKING AN APPROPRIATION TO THE STATE DEPARTMENT OF HEALTH TO FUND THE GATHERING OF EVIDENCE AND THE COST OF TREATMENT REQUIRED BY SECTION SEVEN HUNDRED NINE POINT TEN (709.10), CODE 1977 SUPPLEMENT.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state to the state department of health the sum of fifteen thousand (15,000) dollars, or so much thereof as is necessary, to be used to pay the cost of medical examinations for the purpose of gathering evidence and the cost of treatment for the purpose of preventing venereal disease as required by section seven hundred nine point ten (709.10) of the Code 1977 Supplement.

Sec. 2. Unencumbered or unobligated balances of funds appropriated by this Act remaining on June 30, 1979 shall revert to the general fund of the state.

Sec. 3. This Act, being deemed of immediate importance, shall take effect and be in force from and after its publication in The Waterloo Courier, a newspaper published in
