1 Section 1. Section eight point thirty-nine (8.39), Code
2 1977, is amended by adding the following new unnumbered
3 paragraph after unnumbered paragraph two (2):

4 NEW UNNUMBERED PARAGRAPH. Prior to any transfer of funds
5 pursuant to this section, the state comptroller shall notify
6 the chairpersons of the standing committees on budget of the
7 senate and the house of representatives and the chairpersons
8 of subcommittees of such committees of the proposed transfer.
9 The notice from the state comptroller shall include information
10 concerning the amount of the proposed transfer, the
11 departments, institutions or agencies affected by the proposed
12 transfer and the reasons for the proposed transfer.
13 Chairpersons notified shall be given at least two weeks to
14 review and comment on the proposed transfer before the transfer
15 of funds is made.

16 EXPLANATION

17 This bill requires the state comptroller to inform the
18 chairpersons of the House and Senate standing committees on
19 budget and the chairpersons of subcommittees of such committees
20 of proposed transfers of funds between state departments,
21 institutions and agencies. Chairpersons must be given at
22 least two weeks to comment on the proposed transfer before
23 the transfer may be made.

AN ACT
RELATING TO THE TRANSFER OF FUNDS BETWEEN STATE DEPARTMENTS,
INSTITUTIONS AND AGENCIES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section eight point thirty-nine (8.39), Code 1977, is amended by adding the following new unnumbered paragraph after unnumbered paragraph two (2):

NEW UNNUMBERED PARAGRAPH. Prior to any transfer of funds pursuant to this section, the state comptroller shall notify the chairpersons of the standing committees on budget of the senate and the house of representatives and the chairpersons of subcommittees of such committees of the proposed transfer. The notice from the state comptroller shall include information concerning the amount of the proposed transfer, the departments, institutions or agencies affected by the proposed transfer and the reasons for the proposed transfer. Chairpersons notified shall be given at least two weeks to review and comment on the proposed transfer before the transfer of funds is made.
