RELATING TO THE WITHDRAWAL OF A CITY FROM A COUNTY LIBRARY DISTRICT.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section three hundred fifty-eight B point sixteen (358B.16), Code 1977, is amended to read as follows:

358B.16 WITHDRAWAL OF CITY FROM DISTRICT. A city may withdraw from the county library district by-giving-notice upon a majority vote in favor of withdrawal by the electorate of the city in an election held on a motion by the city council. The election shall be held simultaneously with a general or city election. Notice of a favorable vote to withdraw shall be sent by certified mail to the board of library trustees of the county library and the county auditor prior to January 40 tenth, and ~~on-that-date-shall-cease-to be-a-part-of-or-included-in-the-county-library-district~~ the withdrawal shall be effective on July first.
