A BILL FOR

1 An Act appropriating funds from the motor vehicle fuel
2 tax fund to the department of revenue, from the Iowa
3 public employees' retirement system to the Iowa
4 department of job service for administration of the
5 Iowa public employees' retirement system, and making
6 an appropriation from the general fund of the state
7 for the city finance committee and the Iowa compre-
8 hensive conference.

1 Section 1. There is appropriated from the motor vehicle
2 fuel tax fund to the department of revenue for the fiscal
3 year beginning July 1, 1977 and ending June 30, 1978, the
4 sum of one million two hundred ninety-eight thousand four
5 hundred forty-seven (1,298,447) dollars, or so much thereof
6 as may be necessary, for salaries, support, maintenance and
7 miscellaneous purposes for administration and enforcement
8 of the provisions of chapter three hundred twenty-four (324)
9 of the Code and the motor vehicle use tax program.

10 Sec. 2. There is appropriated from the Iowa public em-
11 ployees' retirement system fund for the fiscal year beginning
12 July 1, 1977 and ending June 30, 1978 for the Iowa department
13 of job service the sum of one million two hundred eleven thou-
14 sand nine hundred twenty-five (1,211,925) dollars, or so much
15 thereof as necessary, for salaries, support, maintenance and
16 miscellaneous purposes to pay the costs of the administration
17 of the Iowa public employees' retirement system.

18 Sec. 3. There is appropriated from the general fund of
19 the state for the fiscal year beginning July 1, 1977 and
20 ending June 30, 1978 to the state comptroller the following
21 amounts, or so much thereof as may be necessary, to be used
22 for the following purposes:

- 23 1. For city finance com-
- 24 mittee \$ 12,000
- 25 2. For Iowa comprehensive
- 26 conference \$ 20,000

27 EXPLANATION

- 28 1. REVENUE. This appropriation from the motor vehicle
- 29 fuel tax fund transfers funds to the department of revenue
- 30 for administrative purposes.
- 31 2. IPERS. This appropriation transfers funds from the
- 32 IPERS fund to job services for the cost of administering the
- 33 IPERS program.
- 34 3. COMPTROLLER.
- 35 a. City Finance Committee. This appropriation allows

1 for continuation of current programs.

2 b. Comprehensive Conference Plan. This appropriation pro-
3 vides funds for this program of the Iowa 2000 planning
4 committee which will enable the committee to conclude its
5 activity this biennium. Funds were previously allocated in
6 the office for planning and programming appropriation at the
7 same level as appropriated in this bill.

AN ACT

APPROPRIATING FUNDS FROM THE MOTOR VEHICLE FUEL TAX FUND TO THE DEPARTMENT OF REVENUE, FROM THE IOWA PUBLIC EMPLOYEES' RETIREMENT SYSTEM TO THE IOWA DEPARTMENT OF JOB SERVICE FOR ADMINISTRATION OF THE IOWA PUBLIC EMPLOYEES' RETIREMENT SYSTEM, AND MAKING AN APPROPRIATION FROM THE GENERAL FUND OF THE STATE FOR THE CITY FINANCE COMMITTEE AND THE IOWA COMPREHENSIVE CONFERENCE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the motor vehicle fuel tax fund to the department of revenue for the fiscal year beginning July 1, 1977 and ending June 30, 1978, the sum of one million two hundred ninety-eight thousand four hundred forty-seven (1,298,447) dollars, or so much thereof as may be necessary, for salaries, support, maintenance and miscellaneous purposes for administration and enforcement of the provisions of chapter three hundred twenty-four (324) of the Code and the motor vehicle use tax program.

Sec. 2. There is appropriated from the Iowa public employees' retirement system fund for the fiscal year beginning July 1, 1977 and ending June 30, 1978 for the Iowa department of job service the sum of one million two hundred eleven thousand nine hundred twenty-five (1,211,925) dollars, or so much thereof as necessary, for salaries, support, maintenance and miscellaneous purposes to pay the costs of the administration of the Iowa public employees' retirement system.

Sec. 3. There is appropriated from the general fund of the state for the fiscal year beginning July 1, 1977 and ending June 30, 1978 to the state comptroller the following amounts, or so much thereof as may be necessary, to be used for the following purposes:

- 1. For city finance committee \$ 12,000
- 2. For Iowa comprehensive conference \$ 20,000
