AN ACT

MAKING AN APPROPRIATION TO THE DEPARTMENT OF SOCIAL SERVICES TO PROVIDE THE STATE'S SHARE OF IMPROVING THE CITY OF MITCHELLVILLE'S WATER SYSTEM AND IMPROVING THE CITY OF INDEPENDENCE'S SEWER SYSTEM.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. There is appropriated from the general fund of the state to the department of social services for the fiscal year beginning July 1, 1977 and ending June 30, 1978, the sum of fifty-seven thousand (\$57,000) dollars, or so much thereof as is necessary, to be used to pay the state's share of costs for improving the city of Mitchellville's water system.

Sec. 2. There is appropriated from the general fund of the state to the department of social services for the fiscal year beginning July 1, 1977 and ending June 30, 1978 the sum of one hundred fifty thousand (\$150,000) dollars, or so much
