1 Section 1. Section eighteen point one hundred sixty-six
2 (18.166), subsection one (1), Code 1979, is amended to read
3 as follows:

4 1. The department shall be the exclusive contracting
5 agency for the purchase of insurance coverage for state loss
6 and risk exposure except for revenue producing facilities
7 under the state board of regents which have to comply with
8 bond covenants and ~~and further provided that any contract for~~

12 EXPLANATION

13 The purpose of this bill is to correct an incomplete
14 sentence which resulted from the amendments to House File
15 545. House amendment H-3956 changed this subsection from
16 its original form, and that amendment was amended by H-3963.
17 The intent of H-3963 appears to have been to delete a
18 requirement that the risk management division obtain the
19 approval of the board of regents for every insurance contract
20 affecting institutions under the board, but that amendment
21 failed to remove all of the language in H-3956 which dealt
22 with the same requirement. This bill removes the language
23 which was rendered surplus by the adoption of H-3963.

24 The bill would take effect July 1, 1979.

10 is amended by striking paragraph b."

11 2. Page 1, by inserting after line 11 the
12 following:

13 "Sec. _____. Section eighteen point one hundred
14 sixty-six (18.166), Code 1979, is amended by striking
15 subsections two (2), four (4) and five (5).

16 Sec. _____. Section eighteen point one hundred
17 sixty-six (18.166), subsection six (6), Code 1979,

23 3. By renumbering sections of the bill.

24 4. Amend the title by striking lines 1 through

28 (18.165) and eighteen point one hundred sixty-six
29 (18.166) of the Code, relating to the duties of the
30 risk management division of the department of general

MAKING A CORRECTIVE AMENDMENT TO SECTION SEVEN (7) OF HOUSE FILE FIVE HUNDRED FORTY-FIVE (545) ENACTED DURING THE 1978 SESSION OF THE GENERAL ASSEMBLY, RELATING TO THE PURCHASE BY THE RISK MANAGEMENT DIVISION OF INSURANCE FOR THE BOARD OF REGENTS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section eighteen point one hundred sixty-six (18.166), subsection one (1), Code 1979, is amended to read as follows:
