2 one (303A.21), subsection two (2), Code 1979, is amended to

7 except correspondence but does not include:

13 sion through the adoption and enforcement of rules pursuant

16 Sec. 2. This Act shall become effective on January first
17 following its enactment.

18 EXPLANATION

19 This bill amends the definition of "state publications"
20 in Code Chapter 303A to allow the State Library Commission
21 to exclude materials from the definition through rule-making.
22 The rules must be necessary for the exercise of the
23 Commission's powers and duties and necessary for the proper
24 administration of the Iowa Library Department. An exclusion
25 by rule would free the depository librarian from the section
26 303A.23 duties of depositing, classifying, listing, indexing,
27 and providing to the State Library Commission, the University
28 of Iowa, and the Library of Congress, materials otherwise
29 defined as "state publications". The bill becomes law on
30 January first following its enactment.
