BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section five hundred seventeen point five (517.5), Code 1979, is amended to read as follows:

517.5 INSPECTION NOT BASIS FOR CIVIL LIABILITY.
