FISCAL NOTE

In compliance with a written request there is hereby submitted a Fiscal Note for H. F. 2027 pursuant to Joint Rule 16.

LSB 3214H is An Act to provide for a special turkey hunting license for owners of farm units and members of the owner's immediate family.

The price of the license is the same as a regular turkey hunting license and is only valid for hunting on the permit-holder's farmstead.

In calculating the fiscal impact of this bill, it has been estimated by the wildlife staff that 500 farmers would apply for the license. Currently, the license costs \$15. The fiscal impact of this bill is estimated at \$7,500 a year in revenue collected from additional license fees (500 licenses @ \$15 each).

17 EXPLANATION

18 This bill establishes a special turkey hunting license
19 for owners of farm units and members of the owner's immediate
20 family. The special license is valid only for hunting on
21 the owner's farm unit. Only one special license may be issued
22 for a farm unit. A person purchasing the regular turkey
23 hunting license is not eligible to purchase the special
24 license. The fee for the special license is the same as the
25 regular license. The special turkey hunting licensee is
26 subject to all other provisions of law regarding the hunting
27 of turkeys. The bill takes effect July 1 following enactment.
