1 Section 1. Section 280A.13, Code 1981, is amended to read
2 as follows:

3 280A.13 DIRECTORS OF MERGED AREA. In each merged area,
4 the initial board of directors elected at the special election
5 shall organize within fifteen days following the election
6 and may thereafter proceed with the establishment of the
7 designated area vocational school or area community college.
8 The board of directors of the merged area shall ~~thereafter~~
9 organize ~~on~~ at the first Monday regular meeting in October
10 of each year. Organization of the board shall be effected
11 by the election of a president and ~~such~~ other officers from
12 the board membership as board members ~~so~~ determine. The board
13 of directors shall appoint a secretary and a treasurer who
14 shall each give bond as prescribed in section 291.2 and who
15 shall each receive ~~such~~ a salary as ~~shall-be~~ determined by
16 the board. The secretary and treasurer shall perform ~~such~~
17 ~~duties as-are-prescribed-in~~ under chapter 291 and ~~such~~
18 additional duties as the board of directors ~~may-deem~~ deems
19 necessary. The frequency of meetings other than organizational
20 meetings shall be as determined by the board of directors
21 but the president or a majority of the members may call a
22 special meeting at any time.

23 EXPLANATION

24 This bill permits the board of directors of a merged area
25 to meet for an organizational meeting during the first regular
26 meeting in October of each year. At the present time, the
27 board is required to meet the first Monday in October of each
28 year.

29 The bill takes effect July 1 following its enactment.

AN ACT

CHANGING THE DATE FOR THE ORGANIZATIONAL MEETING OF THE BOARD OF DIRECTORS OF A MERGED AREA.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 280A.13, Code 1981, is amended to read as follows:

280A.13 DIRECTORS OF MERGED AREA. In each merged area, the initial board of directors elected at the special election shall organize within fifteen days following the election and may thereafter proceed with the establishment of the designated area vocational school or area community college. The board of directors of the merged area shall thereafter organize on at the first Monday regular meeting in October of each year. Organization of the board shall be effected by the election of a president and such other officers from the board membership as board members so determine. The board of directors shall appoint a secretary and a treasurer who shall each give bond as prescribed in section 291.2 and who shall each receive such a salary as shall be determined by the board. The secretary and treasurer shall perform such duties as are prescribed in under chapter 291 and such additional duties as the board of directors may deem deems necessary.
