1 Section 1. WELL INQUIRY. The assessor in each assessor
2 jurisdiction shall, when reassessing property for the 1983
3 and 1984 assessment years inquire of each property owner or
4 tenant whether there are wells on the property, whether they
5 are usable or abandoned and whether the wells are used for
6 drainage purposes. The assessor shall provide the information
7 collected on wells to the Iowa geological survey.

8 EXPLANATION

9 This bill requires the assessor to ask each property owner
10 or tenant in 1983 and 1984 if there are usable or abandoned
11 wells on the property and if they are used for drainage
12 purposes and to provide the information to the Iowa geological
13 survey.

14 The bill takes effect July 1 following enactment.

AN ACT
RELATING TO THE IDENTIFICATION OF THE LOCATION OF WELLS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. WELL INQUIRY. The assessor in each assessor jurisdiction shall, when reassessing property for the 1983 and 1984 assessment years inquire of each property owner or tenant whether there are wells on the property, whether they are usable or abandoned and whether the wells are used for drainage purposes. The assessor shall provide the information collected on wells to the Iowa geological survey.
