## A BILL FOR

1 An Act repealing the provision that area education agencies  
2 must obtain approval from the state board of public  
3 instruction before purchase or lease of equipment or  
4 facilities for media production or reproduction, and  
5 the requirement that area education agencies must contract  
6 with the state educational radio or television facility  
7 board for television production, television transmission,  
8 or closed circuit television transmission.

1 Section 1. Section 273.10, Code 1981, is repealed.

2 EXPLANATION

3 This bill strikes the requirement that area education  
4 agencies must obtain approval from the state board before  
5 purchase or lease of equipment or facilities for media  
6 production or reproduction, and the requirement that area  
7 education agencies must contract with the state educational  
8 radio or television facility board for television production,  
9 television transmission, or closed circuit television  
10 transmission. The bill is effective July 1 following its  
11 enactment.

AN ACT

REPEALING THE PROVISION THAT AREA EDUCATION AGENCIES MUST OBTAIN APPROVAL FROM THE STATE BOARD OF PUBLIC INSTRUCTION BEFORE PURCHASE OR LEASE OF EQUIPMENT OR FACILITIES FOR MEDIA PRODUCTION OR REPRODUCTION, AND THE REQUIREMENT THAT AREA EDUCATION AGENCIES MUST CONTRACT WITH THE STATE EDUCATIONAL RADIO OR TELEVISION FACILITY BOARD FOR TELEVISION PRODUCTION, TELEVISION TRANSMISSION, OR CLOSED CIRCUIT TELEVISION TRANSMISSION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 273.10, Code 1981, is repealed.
