1 Section 1. Section 273.8, subsection 3, unnumbered  
2 paragraph 1, Code 1981, is amended to read as follows:

3 The board of directors of each area education agency shall  
4 meet ~~on-the-first-Monday-in~~ at the first regular meeting in  
5 October of each year at a suitable place designated by the  
6 president. Directors whose terms commence at the organization  
7 meeting shall qualify by taking the oath of office required  
8 by section 279.31 at or before the organization meeting.

12 EXPLANATION

13 This bill allows the board of an area education agency  
14 to hold its annual organization meeting at the first regular  
15 meeting in October rather than requiring that the meeting  
16 take place on the first Monday in October. The bill takes  
17 effect July 1 following its enactment.

RELATING TO THE DATE OF THE ANNUAL ORGANIZATION MEETING OF  
THE BOARD OF DIRECTORS OF AN AREA EDUCATION AGENCY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 273.8, subsection 3, unnumbered  
paragraph 1, Code 1981, is amended to read as follows:

The board of directors of each area education agency shall

president. Directors whose terms commence at the organization

by section 279.31 at or before the organization meeting.
